The Finance Director is an exciting new role with responsibility for overseeing all aspects of financial management of The Sunrise Project across multiple legal entities in Australia, the US and Europe. Working closely with the Chief Operating Officer (COO) in each geography and reporting to the global COO, you'll be responsible for ensuring our financial management, budgeting, forecasting, and reporting systems are efficient, effective, and continually adapt to changing needs of a rapidly growing global organisation. You'll be responsible for managing our external accounting contractors in different geographies and integrating our accounts so that the board and senior managers have an accurate and clear view of our financial position at all times.

About You

You're a qualified accountant and an experienced financial manager with a proven track record of managing the finances of a dynamic and fast-moving organization. You're a strategic thinker and are excited about designing and continually improving financial mgmt. systems to make sure that decision makers at all levels of the organisation have the financial information they need to plan and implement with confidence. While you're great on the financial detail, you're also a structured thinker and a great communicator who can convey complex financial information in simple ways.

You may have worked as a financial manager in an NGO before, or maybe you've worked exclusively in the private sector. Either way, you're passionate about putting your first-rate financial management skills to use to help solve the climate crisis.

- Overall financial management of The Sunrise Project including integration of budgets, forecasts, and reporting across different legal entities in Australia, the US and Europe;
- Manage all financial services providers in Australia and support the COO in the US and Europe to manage external financial service providers in those geographies;
- Oversee and lead the annual budgeting and forecasting process and continually improve our financial planning systems to enable the board and senior managers to plan with clarity and confidence;
- Develop and present regular financial reports to the board, senior managers and budget holders in a way that clearly communicates key information in simple ways;
- Develop, implement, and maintain all necessary policies and practices to ensure sound financial management, good governance, and compliance with relevant accounting standards;
- Produce financial reports for donors as required;
- Oversee the independent audit for each Sunrise Project legal entity;
- Implement and maintain a robust contracts management system including grants management;

Required Skills and Experience

- Relevant accounting qualifications such as CPA or equivalent;
- At least ten years' experience as a financial management professional in a similar role;
- Demonstrated experience in designing and implementing budgeting and forecasting systems;
- Ability to communicate complex financial information in simple ways to people who do not have a financial background;
- Keen analytical problem-solving skills to support sound decision making
- A high degree of flexibility with a demonstrated track record of working well in small teams in a fastpaced environment;
- A high degree of emotional intelligence and excellent interpersonal communication skills;
- A passion for action on climate change and a commitment to social justice, equity, and inclusion; and
- Full working rights in Australia.
