About SAB Foundation

The SAB Foundation is an independent trust that invests millions of rands annually in the entrepreneurial development of black entrepreneurs in South Africa, with a focus on social innovation. Established in 2010 as part of a broad-based black economic empowerment transaction by South African Breweries Ltd (SAB), the Foundation aims to economically and socially empower historically disadvantaged individuals by funding small, medium, and micro-sized enterprises (SMMEs).

The Foundation is governed by a board of trustees comprised of respected South African businesspeople. Initially, it held 8.4 million SAB shares and utilized dividend income from these shares to benefit the South African community at large. Notably, it was the first organization in South Africa to be recognized as a tax-exempt Small Business Funding Entity (SBFE) under section 10(1)(cQ) of the Income Tax Act.

Focusing on women, youth, rural populations, and individuals with disabilities, the Foundation provides both financial and strategic support to SMMEs. By March 2024, the SAB Foundation had invested over R784 million in supporting 7,543 entities. This investment includes R449 million in grants, R247 million in business development support, R45 million in interest-free loans, with R13 million repaid to date, and R88 million in low-interest rate loans with 9 million repaid to date. Through these efforts, the Foundation significantly contributes to job creation, community building, and addressing social issues in South Africa.
